The Township was awarded the Recreation Passport Grant from the DNR in the amount \$56,000 to help facilitate phase 1 of Casco Belle River Park. Located on Fred Moore Hwy.



Our Township Clerk, Jennifer Andersen applied and was awarded ARPA, Covid Relief money. The first installment was received in 2021 in the amount of \$213,122.35. The second installment will be received around Nov. 2022, for \$212,268.00.


#### FRIENDLY REMINDER:
