#### **OLD BUSINESS:**

- 1. Solar Power Discussion
- S. Cassin discussed that the Renewable energy sitting legislation passed and will be signed by the governor in the next few days. He explained that it will take away local control from the township. Also, the township can't have ordinances that are more restrictive than the state's requirements. The legislation applies to all solar projects with a nameplate capacity of 50 megawatts or greater. It takes about 2.5 acres for every megawatt. There is a one-time \$2000 per megawatt payment provided from the energy facility owner to the local unit for public safety and infrastructure purposes: however, both parties (the local unit and the energy facility owner) must agree on how the funds can be spent.

The Commission discussed possible options the township can take.
