Casco Township is in the process of updating its Master Plan.

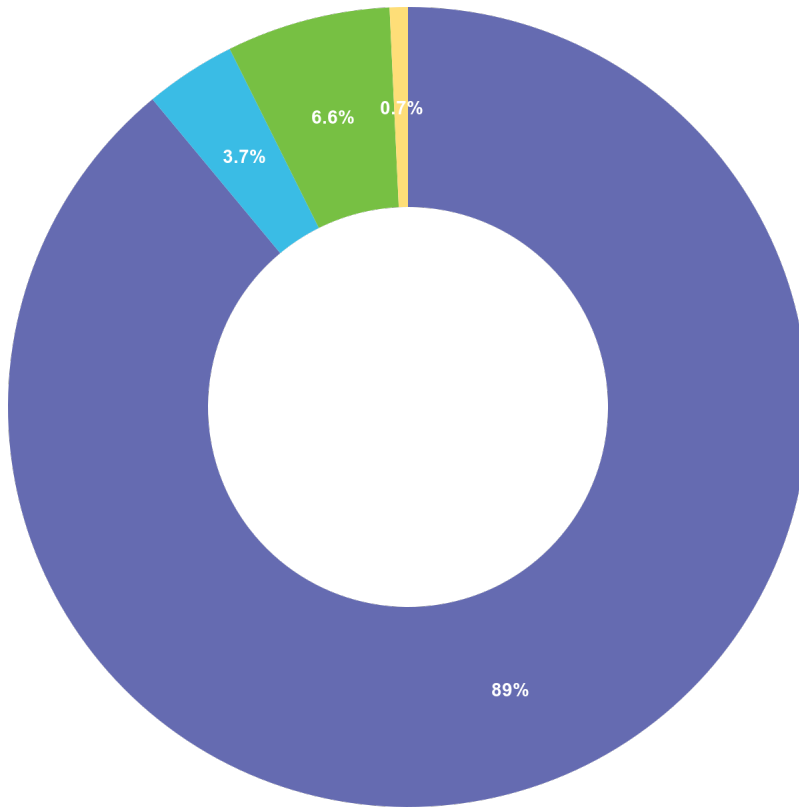

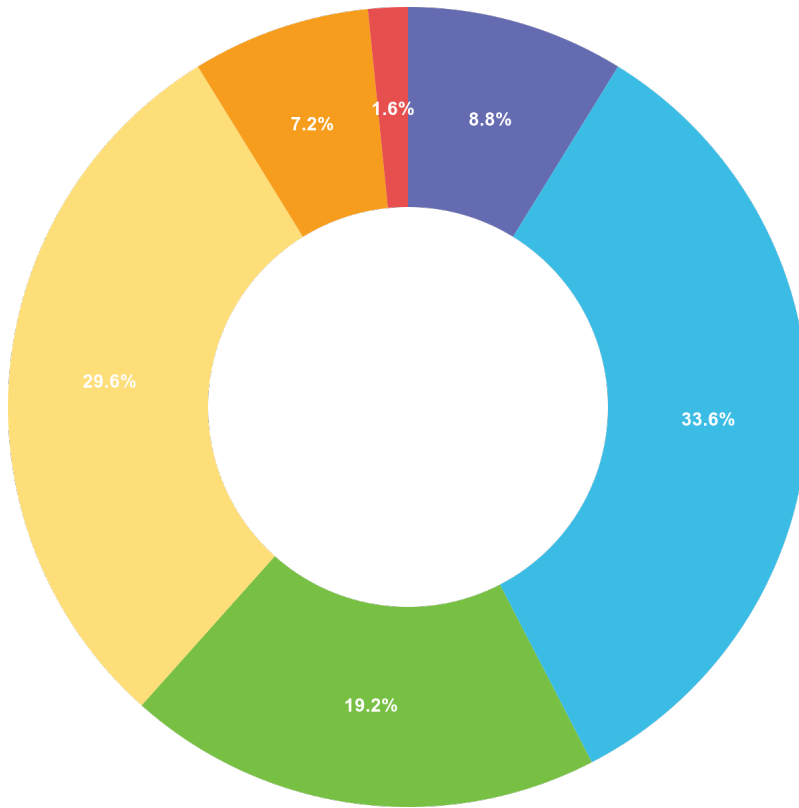
Q1 What is your affiliation with Casco Township? (Please check all that apply)

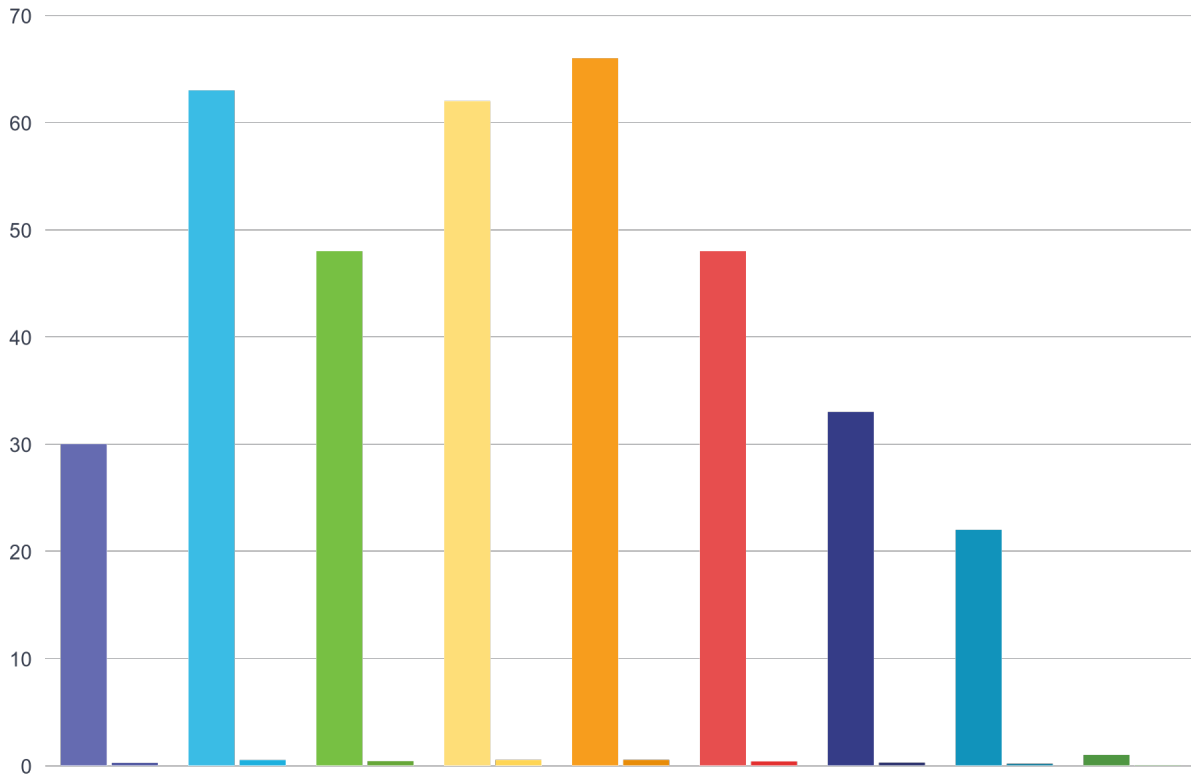
Q2 2. How many people live in your household?

Q3 Please indicate the number of people in your household within each of the following age groups.

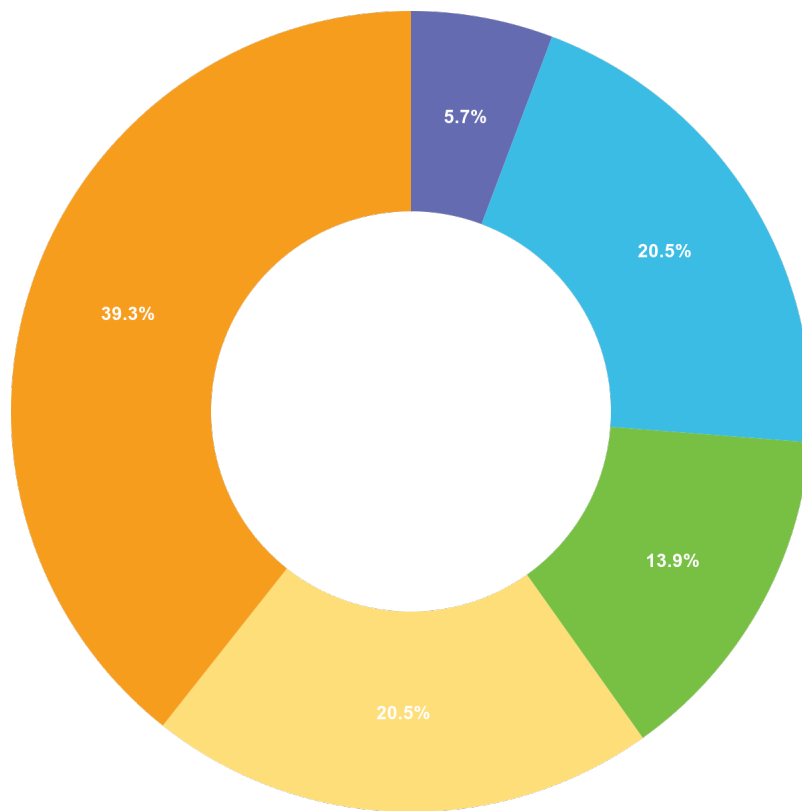

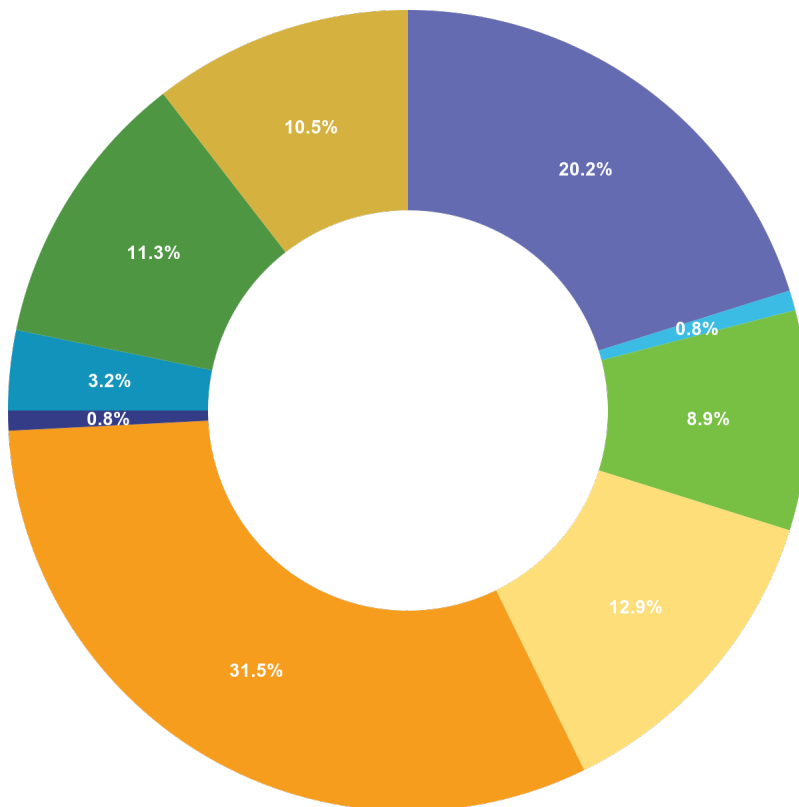

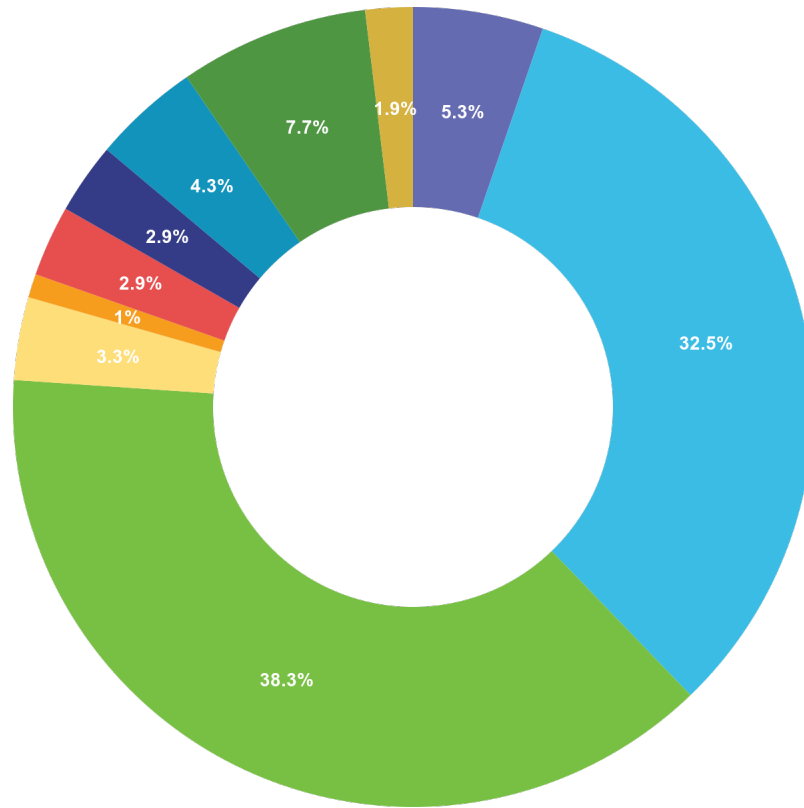
Q5 Where is your place of employment located?

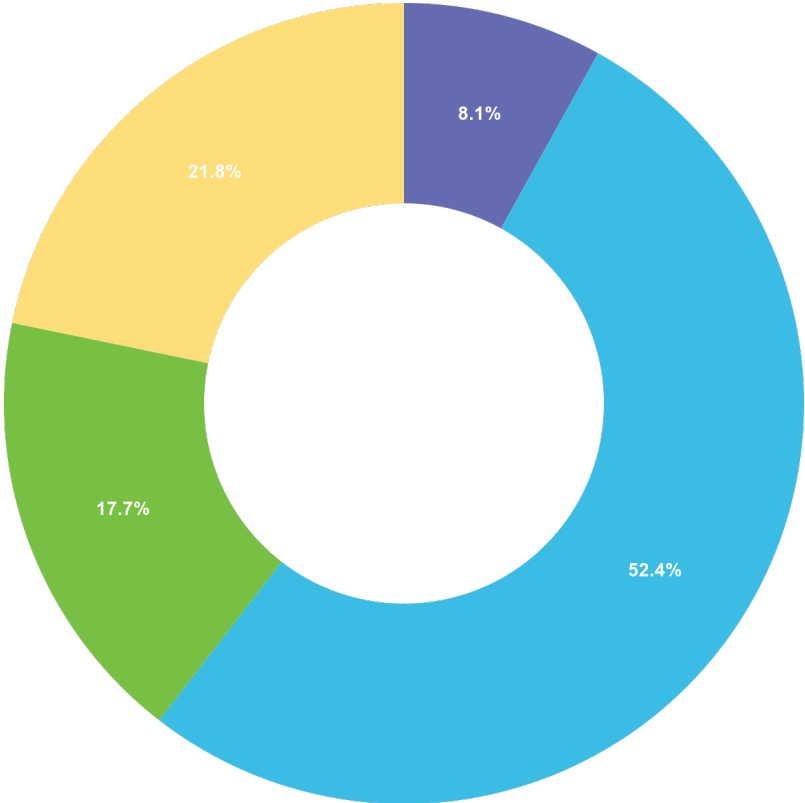
Q6 What type of housing would best serve the Township's future needs? Select all that apply.

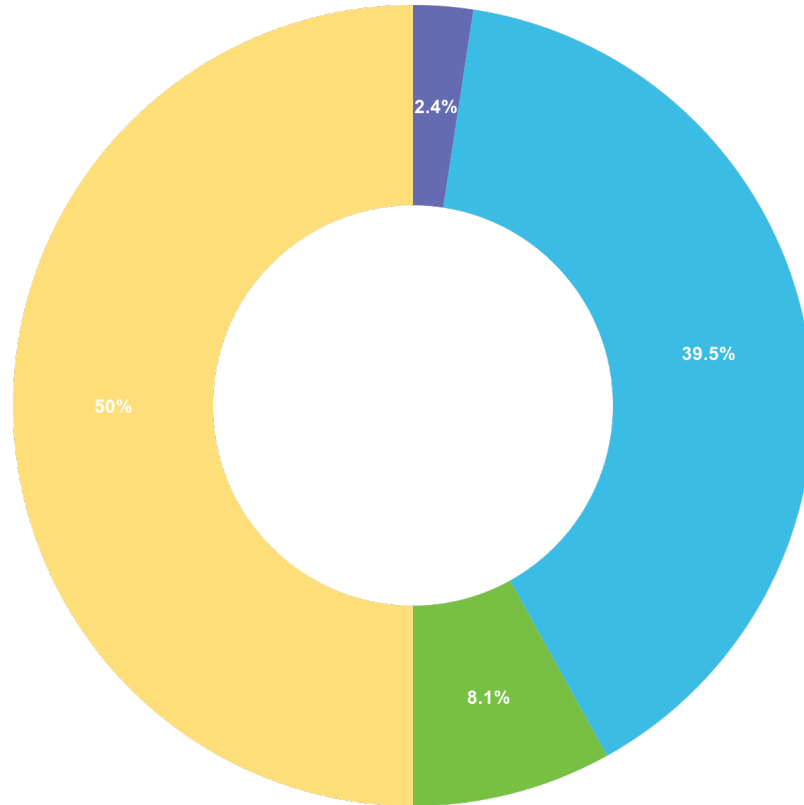
Q7 What strategy would you prefer for **Residential** growth in Casco Township?

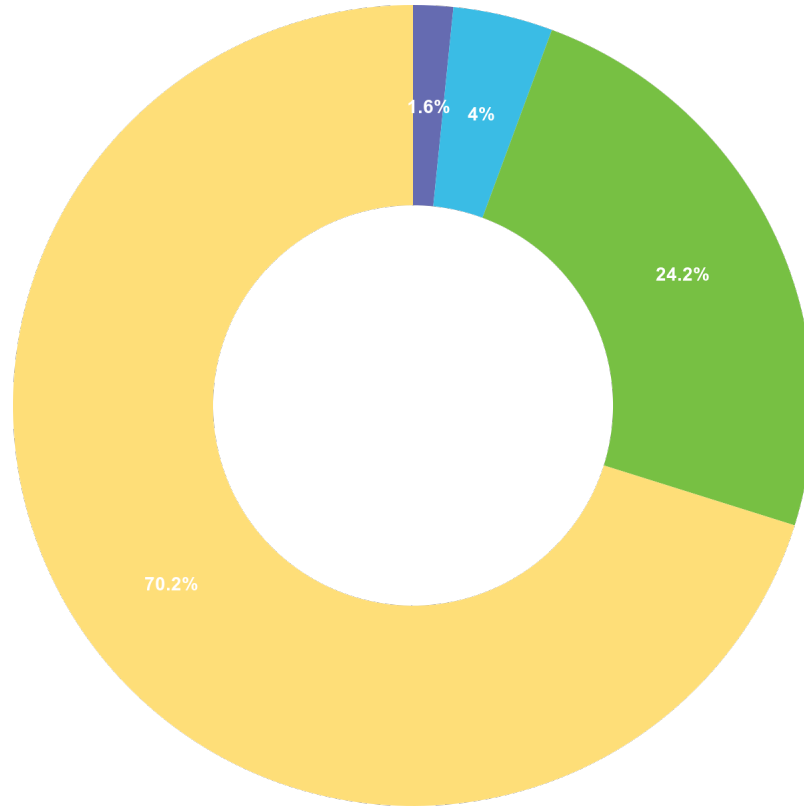
Q8 What strategy would you prefer for **Commercial** growth in Casco Township?

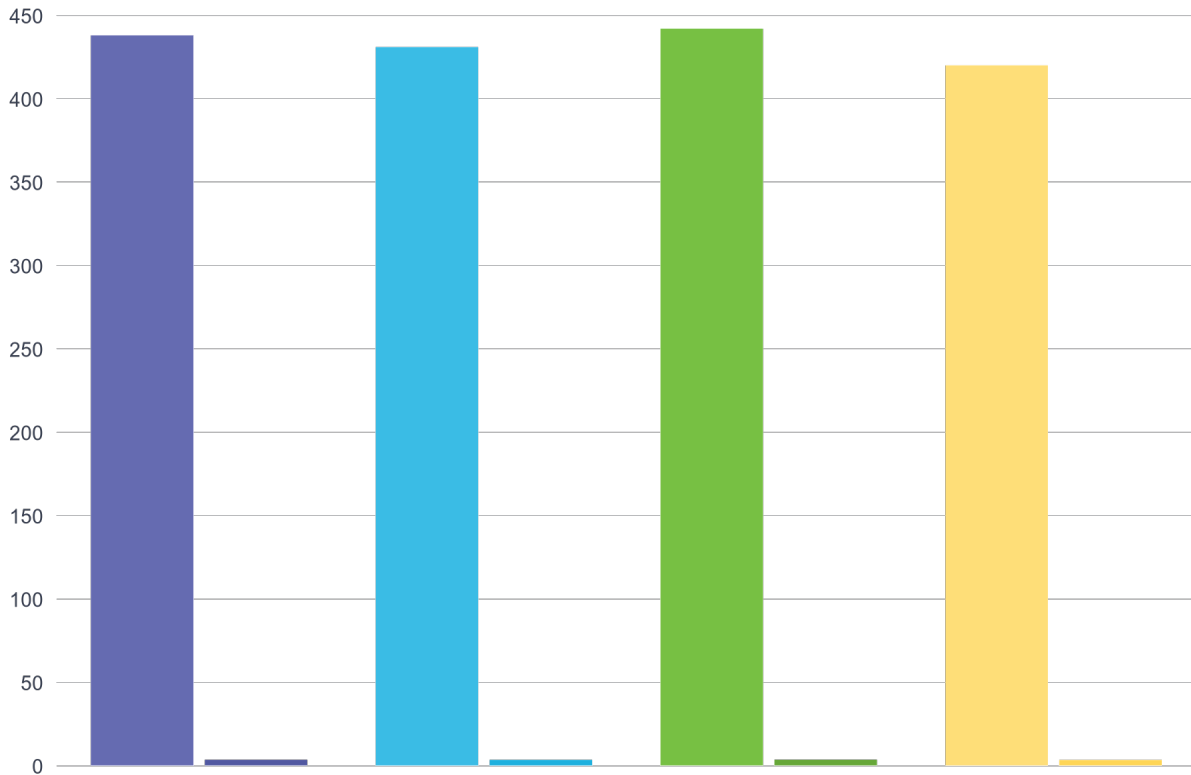
Q9 What strategy would you prefer for **Industrial** growth in Casco Township?

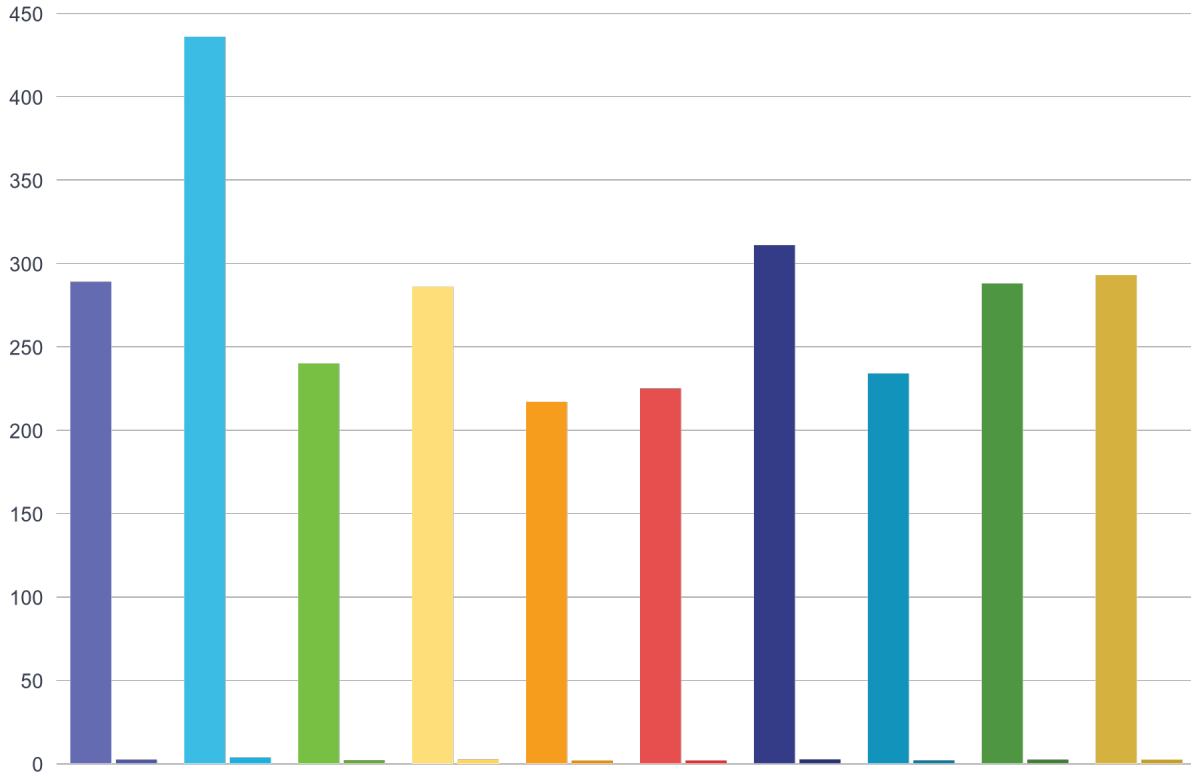

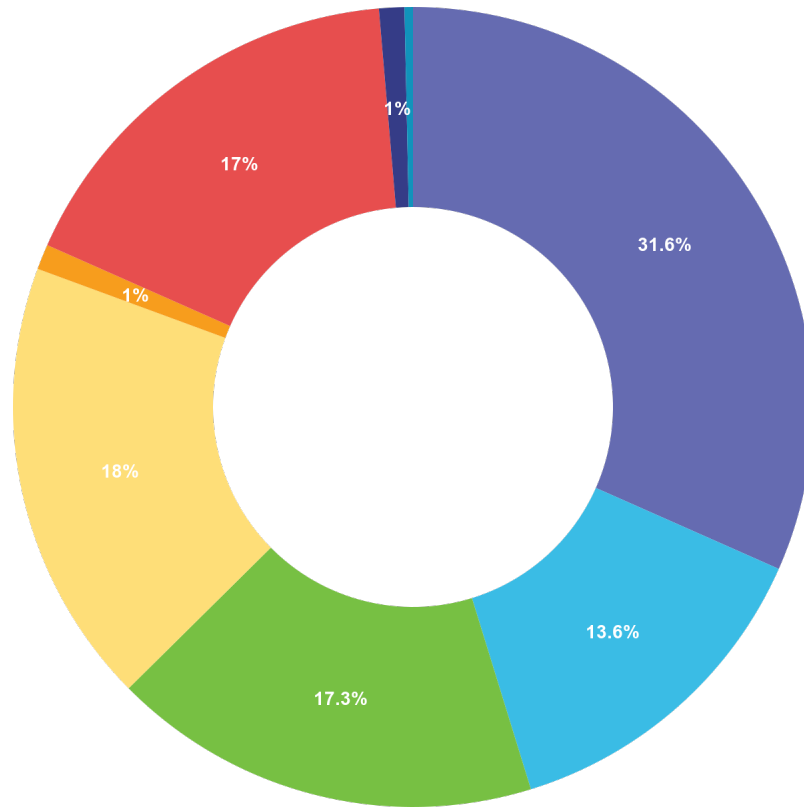
